WHEREAS:

(A) RP Europe Limited ("the company") proposes to enter into the agreement with [name of plc /limited company /partnership/sole trader] ("the Dealer") set out in this dealer registration form in relation to the appointment of the Dealer as a dealer for the equipment and services described therein ("the Agreement") and to supply the Dealer with stock of mobile phones from time to time.

(B) In order to induce the Company to enter into the Agreement and other commercial arrangements with the Dealer the Guarantor(s) has/have agreed to guarantee the obligations of the Dealer to the Company as set out below.

NOW IT IS AGREED as follows:

- Each Guarantor hereby unconditionally and irrevocably guarantees to pay to the Company all the money which is now or may at any time after the date of this Deed become due or owing to the Company by the Dealer pursuant to the agreement or otherwise ("Indebtedness").
- As a separate and independent obligation each Guarantor as a principal obligor agrees to indemnify the Company against any losses, expenses or damages suffered as a consequence or in connection with the Company having now or at any time in the future permitted the Indebtedness to occur or continue.
- If the Dealer defaults in payment in any indebtedness when due the Guarantor(s) shall pay to the Company on demand an amount equal to the amount so unpaid. A certificate by a director of the company of the amount payable shall be conclusive unless manifestly incorrect.
- The Company shall not be obliged to take any action or obtain judgment against the Dealer before taking steps to enforce any of its rights or remedies under this guarantee.
- The liability of the Guarantor(s) under the guarantee shall not be released or diminished by any variation in the terms of the agreement or by any time or any other concessions given to the Dealer by the company or by anything the Company may do or omit to do which, but for this provision, would or might discharge the Guarantor(s).

- The Guarantee shall be a continuing guarantee, shall not be discharged by any intermediate settlement of indebtedness, shall remain in effect until the indebtedness is discharged in full and shall inure to the benefit of the Company and it assigns.
- The Guarantor(s) shall reimburse the Company on demand the reasonable legal costs and out of pocket expenses incurred by the Company in connection with the preparation of this Deed and the enforcement of any of its terms.
- If there is more than one Guarantor, the liability of each individual Guarantor shall be joint and several.
- Any demand or notice on this guarantee shall be in writing signed by an officer of the Company and may be served on the Guarantor(s) personally at the address(es) set above or any other place where the Guarantor(s) may be present or sent by certified post using the correct name and address of the Guarantor(s). Any demand or notice delivered personally to the Guarantor(s) shall be deemed to have been delivered immediately upon receipt and any demand or notice sent by post shall be deemed to have been received 3 days following the date of despatch.
